## Terms & Conditions

1. The tenders should accompany 5% call deposit in shape of Bank draft/deposit at Call in the name of Accounts Officer, NIFA, Peshawar. The earnest money will be retained for a maximum period of 06 months for equipment having value of Rs.50,000/- or more after delivery of material/Commissioning of equipment and will be released on satisfactory performance of the equipment.
2. The rates quoted should be inclusive of all Govt. taxes including GST where applicable, however it should clearly be mentioned whether GST is included in the quoted rates or not. If not mentioned it will be presumed that GST is included in the quoted rates and reasons whatsoever will not be accepted after opening of bids.
3. The rates quoted should be up to premises of NIFA, Tarnab, Peshawar
4. The supplier will provide after sales service during warranty period. The warranty should be clearly indicated.
5. Delivery period should be clearly mentioned.
6. The supplier if fails to provide the ordered material within the specified delivery period, the supply order will be cancelled and ordered materials will be purchased at the risk & cost of the supplier and their earnest money will also be forfeited. The earnest money will also be forfeited if the supplier is backed out after opening of bids.
7. Supply if made after delivery period, liquidated damages @2% per day of the un-supplied store will be recovered from their bills. The total recovery will however not be more then 10% of the total face value of the contract.
